Treasurer's Report

Association had \$4804.15 in expenses. \$13,637.16 budgeted as there still remains roadwork that is uncompleted. Legal fees year to date are, owner legal fees \$758.33 and OCI \$2,974.13. The resident lane was repaired at a cost of \$19,496.10, which was paid by OCI.A total of \$78,016.87 has been spent of the \$95,460.12 budgeted through July 2019.

New Business

The budget and dues were brought up by residents in attendance. A dues increase was discussed, with the current obligations a deficit of \$13,538.18 will occur. With a 10% increase the deficit would be reduced to \$74.52 which could be taken from one of the line items in order to balance the budget. The homeowners in attendance were in favor on an increase. A vote by the Board will take place during the September 26th meeting.
