Treasurer's Report – Maria Baronich

Total deposits for the month of December were \$59,851.74 and per GNO deposit records \$59,548.26 was 2020 homeowner dues leaving \$303.48 received for miscellaneous income (\$195 gate card income and \$108.48 homeowners paying on past due accounts).

The bank balance on the Dec. 31 Balance Sheet of \$67,865.77 includes the \$59,548.26 2020 homeowner dues so the balance on hand at Dec. 31 without the 2020 dues was \$8,317.51. There was also \$5,553.00 paid in January for December services so the actual funds that would have been left when including the December invoices would be \$2,764.51 as our carryforward amount into 2020.

Management Company Report – DJ Audibert

Home at 14142 Riverlake has had a sink hole reappear and called GNO. Repairs will be completed 1/27/20 weather permitting. GNO is still promoting WEBAXIS, 144 homeowners have signed up.

Old Business

Trey Lape will file with the court for reimbursement of all OCI legal fees associated with the repairs to the Resident lane.

New Business

GNO will sending out an email on or about 2/1/2020 advising owners they need to pay by 2/15/20 or \$39 late fee will be added to the amount they owe.

A homeowner proposed the late fee should be a monthly charge. The Board members present discussed this as a possibility and all Board members present agreed to further discussion on the proposal, to include notification to the owners and a future implementation date.
