Treasurer's Report – Maria Baronich, Treasurer

Treasurer's Report for April 23, 2020 / April 27, 2020 HOA meeting

Report is based on actual cash transactions for March.

Operating account bank balance on 3/1/20 was \$106,562.82

In March our net deposits were \$6,757.58

March paid expenses totaled \$13,172.96 leaving a March 31, 2020, balance in the operating account of \$100,147.44. Additional March expenses included attorney fees in the OCI lawsuit to pursue recovery of prior attorney fees and to address the construction access road between the entrance and Phase IV-A.

Old Business

Dumpster – David Caldwell

Pontchartrain waste will provide a "wheeled" dumpster which will be less cumbersome than the large stationary dumpster provided in prior years. The Board will investigate a location somewhere other than the front entrance due to the unsightliness and misuse from prior years.

Main water leaks:

Since our last meeting Artesian Utility repaired the water leak at 13247 Riverlake; however, there is a new leak today (April 23) at that same location that Artesian will need to repair.

The Board continues to monitor and contact Artesian Utility to repair the major water line leaks that have not been repaired.

D. Guidry of Artesian Utility advised that surveyors for Artesian are mapping the sewer and water systems and are marking with bright pink paint/flags.

The tall center sodium boulevard lights are not working property. This repair should be paid for by OCI. D. Guidry was contacted to have lights repaired.

Notes:

Be advised that Pontchartrain Waste will pick up large items (i.e.; washer, dryer, etc) <u>if called</u>. The owner needs to advise them that you live in Lake Ramsey. This service is provided to Lake Ramsey customers only by contract. They will tell the owner what day they will do the pickup. <u>Please do not place the items out for pickup until the night before or the day of the scheduled pickup.</u>

Pontchartrain Waste will not pick up construction/renovation debris as part of the normal trash pickup schedule. The owner needs to call Pontchartrain Waste (Brandon) and discuss what he will pick up for free or what he will charge for. Things like pruning of trees/shrubs, tree removal etc. are in this category. Pontchartrain Waste is very reasonable on what he charges.
