NARRATIVE CONTINUATION

On June 14, 2103, at approximately 2323 hours, Deputy Steve Plaisance, assisted by Sergeant Emile Lubrano and Deputy Harrison Littleton, was dispatched to the front entrance of the Lake Ramsey Subdivision in Covington, Louisiana. A report was made that an unidentified subject in a Gorilla costume had been walking in front of vehicles entering the subdivision.

Central Dispatch relayed information that the subject in the Gorilla costume had crossed from the southeast side of the roadway and entered the wooded area on the northwest side of the roadway inside the gates of Lake Ramsey Subdivision.

Upon arrival, Deputies began searching the wooded area and roadway near the front gate of Lake Ramsey Subdivision. Deputy Plaisance observed a worn trail approximately 100 yards from the Lake Ramsey gate. Deputy Plaisance drove on the trail and located to his right another trail. Utilizing his spot light, Deputy Plaisance observed five white males in the wood line on the ATV trail. The subjects were standing next to three ATVs and a golf cart.

Deputy Plaisance exited his vehicle, followed by Deputy Harrison Littleton. Deputies requested the five subjects exit the wood line to which they complied. Deputy Plaisance immediately observed a gorilla costume in the rear compartment of the golf cart.

Upon request, the subjects identified themselves as:
 Jake Dematteo, dob 09-17-1965

 Mitchell Allan Horne, dob 06-16-1977
 Chris Cuadrado, dob 08-10-1970

Deputy Plaisance advised the group of the reported person in the gorilla costume. Mr. Horne spoke for the group and advised it was [REDACTED] in the gorilla costume. Mr. Horne went on to explain it was a prank in an attempt to get a Lake Ramsey Subdivision Homeowner to post a "Bigfoot sighting" on the Lake Ramsey Internet Forum. Mr. Horne stated at no time did the group have any intentions of causing harm to anyone. The group was very apologetic and promised they would never perform the prank again. Mr. Horne additionally gave the gorilla costume to Deputy Plaisance to prove that they would never perform the prank again. This was done voluntarily and with several apologies from the group.

Deputy Plaisance performed an NCIC inquiry on the five subjects. The results are as follows: Jake Dematteo, [REDACTED] and Chris Cuadrado, did not have any open arrest warrants. Central Dispatch advised Mitchell Allan Horne had an open arrest warrant for CCRP 21, failure to appear on a civil issue. Mr. Horne advised he had a furniture store that went out of business and he missed his court date. He explained he was consulting with his legal counsel in order to obtain a new court date.

The five subjects were released from the scene. Mr. Horne was advised to contact the St. Tammany Parish District Attorney's Office the next business day.
