Treasurer's Report: presented by Jeff Burton, Treasurer

- Jeff reported that after the first month of the fiscal year there is not a lot to report. Good news, our General Liability insurance went down this year by \$731.58. Nice way to start the year! Jeff originally stated this insurance had gone up, but that was a miss read of the reports.
- The Board has committed to an annual restocking plan. This January five hundred 4" to 8" tiger bass were added to the lake at a cost of \$2524.25. We also have a lake sur vey planned through Mark McElroy and Aquatic Solutions.
- We have been receiving dues all month and our end of January balance was \$82,652.39. Late notices have gone out for February. As always, the Board will pursue collections on all home owner dues through our attorney.

## **Management Company Report** – given by Dave Caldwell (see attached)

- A new information sign has been ordered and is scheduled to be installed shortly, weather permitting. Also, new flag poles will be installed.
- President Dave Caldwell has begun receiving quotes on the repair of the boat dock. The first quote was \$35,000.00. Some pilings will need to be replaced and the placement of the stringers corrected, as well as, new deck boards.
- OCI has performed temporary repairs to the street at the resident's entrance gate.
- Gates have been operating without incidents. A new strobe light has been ordered and will be installed as soon as it is received.
- Repair or replacement to several street signs is being undertaken.
- Neville Dolan reported that several lots are marked with the incorrect lot number, this will be reported to GNO Management for correction.
- A letter to the residents is being prepared and will include instructions on the new lock at the boat launch.
